Background: Family Impact Seminars

- Originally designed to inform federal policymaking in the 1970s, the seminar model was adapted for use with state policymakers.
- Implemented initially in Wisconsin in 1993, state-level seminars have proven effective in taking research findings from university labs to the legislature in 25 sites across the country.
- Located at the University of Wisconsin-Madison, the National Policy Institute for Family Impact Seminars provides policymakers and professionals with nonpartisan, solution-oriented research and a family impact perspective on many complex issues.



Background: Family Impact Seminars

- Non-partisan, non-ideological objective seminar series;
- Family focus brought to state policy making;
- Implications that public issues, policies or programs have for families analyzed; and
- Topics change from year-to-year.



Background: Family Impact Seminars

- Goal of the Seminars:
 - To bring state legislators the expertise of nationally recognized professionals who have special knowledge, through research or practice, of an issue that legislators have determined to be a topic of particular, current interest to the public.
