#### Call to Order

The meeting was called to order by Senator R. Edward Houck, Chairman. Senator Houck directed JCHC members' attention to the memorandum dated August 31, 2009 from Richard J. Bonnie, L.L.B., Chair of the Commission on Mental Health Law Reform regarding "Proposed JCHC Study of Mental Health Issues in Higher Education." In response to the proposal, Delegate Bulova asked that issues related to allowing high schools to share information about students' mental health with colleges and universities as introduced by Delegate Peace (e.g. HB 752) be considered in the study, if approved by JCHC. As explained in the memorandum, Mr. Bonnie will present a well-developed proposal for members to consider during the JCHC meeting on October 7<sup>th</sup>.
