The BHC Subcommittee meeting was called to order by co-chair, Delegate Harvey Morgan.

#### **History of Involvement with ASD Issues**

Kim Snead pointed out that a fact sheet regarding autism spectrum disorders (from the Centers for Disease Control) was included in the members' notebooks as was a brief history of the BHC Subcommittee's involvement with issues related to ASD. Ms. Snead discussed the history and entertained questions and comments.

Senator Houck noted that the SFC Health and Human Resources Subcommittee had addressed ASD issues for the past two years and that he wanted to have that work added to the history. The SFC-HHR Subcommittee will hear several presentations on this topic during its August 24<sup>th</sup> meeting at VCU. In addition, Senator Houck stated that he sponsored legislation in the 2010 session that would have created a legislative committee to review and address ASD services. The resolution passed the Senate but was left in the House Rules Committee

Delegate Morgan indicated that he has met with Delegate O'Bannon and Bob Bradshaw (representing the insurance industry) concerning issues surrounding children with ASD. He asked if anyone on the BHC subcommittee would be interested in developing a concept to establish a fund that provides services for ASD families. This concept would be based on the model followed by the college prepaid fund. Delegate Bulova, Delegate Dance, and Senator Houck said they would be interested in participating in an ad hoc group on this issue.

## **DBHDS Priorities and Behavioral Health Care Updates**

James W. Stewart, III, Commissioner of the Department of Behavioral Health and Developmental Services spoke on the following topics:

- Development of comprehensive plan for children's mental health services
